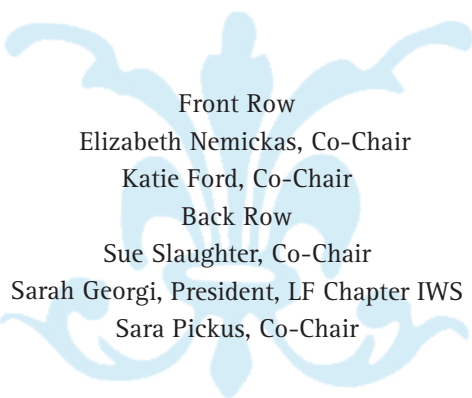

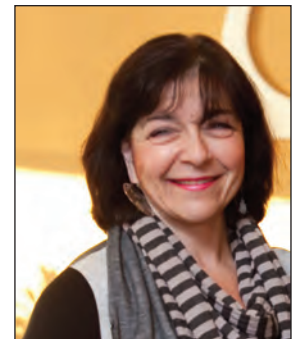

OUR MISSION

Our mission is to provide a continuum of integrated, quality, and preventive health care services to children and their families, enabling them to lead healthy and productive lives.



For more than a century, Infant Welfare has pioneered innovative medical and behavioral health practices to serve some of Chicago's most vulnerable families.

Since 1924, it has incorporated child development and behavioral health counseling into its primary care model, and since 1970 it has provided pediatric dentistry services to low-income children. Orthodontic care was introduced in 1991 and pediatric optometry in 1995. In 2015, IWS launched the Child-Centered Health and Advanced Therapies (CHAT) Center, an on-site prevention program for children at risk for developmental delays.

Our innovative healthcare model provides primary medical care, dentistry, optometry, child development and behavioral health services in a single central location. This "one-stop-shop" ensures barrier-free access to services and provides a multi-service healthcare home to medically underserved children and their families.

TWO PATIENT STORIES

PEDIATRIC CLINIC



A mom and dad describe why they feel so comfortable at IWS . . .

"What you do here helps out a lot of families. It's really helped us a lot. Everyone goes beyond. The people who give the shots, everyone in the lab area - everyone is wonderful. The building is clean, with a pleasant atmosphere.

We have relationships with everyone - the receptionist, scheduler and all the providers. There's a close bond. We're not just anonymous. We were at another place once and it was very cold, not a welcoming place at all. It was not at all welcoming to kids.

Here, Kids can be kids."

DENTAL CLINIC

A mom and dad take their child to the dentists regularly for checkups and preventive care. When the dentist realized that our patient needed braces, she made an appointment with our orthodontist, Dr. Bernie, who started with IWS over 24 years ago.

Dental Assistant Angie and Dr. Hall remember that Dad gave them big hugs and was thrilled and relieved to find out that, thanks to a grant and private donations, IWS offers low-cost braces for families in need.

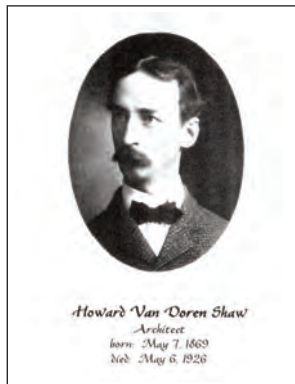

Howard Van Doren Shaw

Howard Van Doren Shaw was born on May 7, 1869 to Chicago businessman T. A. Shaw, a successful dry goods businessman and Sarah Van Doren Shaw, a talented artist of her time. Shaw attended the Harvard School, went on to Yale University and matriculated with the class of 1890. From there he went to the Massachusetts Institute of Technology for his architectural training.



After returning to Chicago in June 1891, he joined the Jenney & Mundie firm. William Le Baron Jenney was emerging as an innovating designer, creating the first skyscrapers. His firm was already gaining a reputation as a training ground for new architects, such as Daniel Burnham and Louis Sullivan.

In 1894, Shaw established his own practice. Shaw's first major commission was for Richard R. Donnelley, cofounder of Lakeside Press. Today it is recognized by the National Park Service as a historic place.

In 1897, Shaw bought a one-third share of a 53-acre farm on Green Bay Road in Lake Forest. Lake Forest had been a rural community to the north of Chicago, but was recently becoming a retreat site for the wealthy following the completion of the Onwentsia Club in 1895. Shaw built a house for his family on the farm, and built houses for Dr. William E. Casselberry and Dr. Nathan Smith Davis, Jr., the other two owners of the property. These houses exhibited Shaw's first forays into the Arts and Crafts Movement.

Undoubtedly one of the most noted properties by Howard Shaw in Lake Forest is his own home, Ragdale. This classic English Country House best exemplifies the charm and

grace of his architectural talents. Today it is considered one of the best examples of Arts and Crafts architecture and is listed on the National Register of Historic Places. Shaw became interested in the movement after holding a joint exhibition for Chicago architecture and Arts and Crafts designers at the Art Institute of Chicago.

In the early 20th century, Shaw became the most recognized designer of country houses in Lake Forest. He typically designed houses either as an elongated rectangle, or as a building surrounding a courtyard. Shaw preferred to do the landscaping himself, but also collaborated with renowned landscape architect Jens Jensen.

In 1910, Shaw moved his offices into the Mentor Building. Shortly thereafter, one of his top students, David Adler, left the firm to start his own practice. Shaw's Market Square in Lake Forest, Illinois was the nation's first planned shopping center in the United States designed for vehicles. Market Square today greets visitors to Lake Forest with its charming facades, graceful towers and a fanciful fountain.

During Howard Shaw's thirty-two year career he was commissioned to build more than thirty-five residences in Lake Forest alone. Of these, nearly all are extant and many have been fully restored to their original grace and splendor.



2017 Showhouse History



This Historic Preservation Award winning Howard Van Doren Shaw English Country Estate is set on over two acres close to Lake Michigan and Shaw's Market Square.

The house was built in 1922 as a summer residence for James O. Hinckley. Rich in Arts and Crafts details, the house is reminiscent of Shaw's own Lake Forest summer home Ragdale. This amazing 5 bedroom, 5.1 bath home with coach house, heated garage, and charming spaces to entertain or relax in, both inside and outdoors is featured in Stuart Cohen's new book "Inventing the New American House, Howard Van Doren Shaw, Architect".

The owners purchased the home in 2007 and have used Shaw's rendering of the front elevation for reference to restore many details of the original design, such as a fireplace and stone arches that had been covered by earlier renovations. Mercury glass window panes, no longer available here, were imported from England.

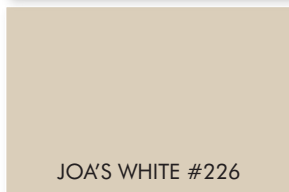
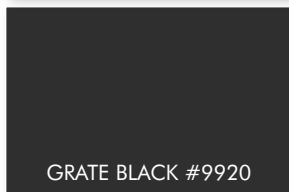
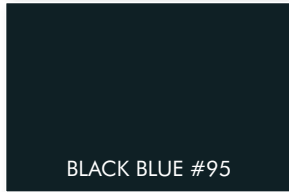
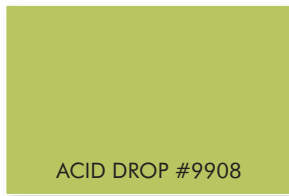
The home's exterior sand finish stucco was carefully repaired but not washed lest the near century old patina be lost. The focal point of the restoration is a sunken English garden and patio. Set below two massive elms, the decaying bluestone garden and patio surfaces were removed, cement repoured and stone reset. A fountain, which had not operated in years, was rebuilt and a bronze statue of a playful girl skips atop the bubbling water.
